- 2. Purchase additional 86 TPT scarves to be available to all members if at all possible at the Renmark Reunion in August 2024

These will be available at a nominal cost to cover postage to those members unable to attend

3. Provide funding to Australian Army Museum Bandiana NSW where our Mark 5 Truck has been restored and housed indoors with a small display of 86 TPT memorabilia.

With the view of a creating a larger static display of the mark 5 Truck, Land Rover with a M60, recreation of the original sign to the entrance of our yard at Vungtau, and "you are entering cobra territory" sign.
